INSURANCE	<p>The Organizing Committee and the IFAGG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. IFAGG Technical Regulations foresee that all participating Delegations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation. The Organizing Committee will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy).</p>
MEDICAL SERVICE	<p>Organizing Committee will provide a first medical aid service, a doctor and emergency medical transportation in the competition area.</p>
COVID-19	<p>With 3-G proof, entry into Austria from countries with a low epidemiological risk is possible without registration and quarantine. If entering the country without 3-G proof, registration for pre-travel clearance and testing within 24 hours of entry is mandatory.</p> <p>From August 18, 2021, proof of vaccination within the meaning of the 3-G rule applies to immunizations with two partial vaccinations only after receipt of the second vaccination for 270 days from the second vaccination date. Immunization through a vaccination continues to be valid as proof of vaccination for 270 days from the 22nd day after vaccination.</p> <p>Entry from virus variant areas (Brazil, Eswatini, Lesotho, Malawi, Mozambique, Namibia, Zimbabwe and Uruguay) is prohibited, with the exception of Austrians and people with residence or habitual abode in Austria. Entry for humanitarian reasons or in the urgent interest of the republic is also possible. There are also other exceptions. Entry is only possible with a negative molecular biological test result (e.g. PCR test). This is also mandatory for vaccinated people. Furthermore, they have to complete a PTC registration and immediately start a ten-day quarantine. The quarantine can be ended from the fifth day after entry (day of entry = day "zero") with a negative molecular biological test result (e.g. PCR test) or by submitting a new medical certificate.</p> <p>When traveling for professional reasons and when traveling in the predominant interest of Austria - especially in the field of culture and sport, e.g. for supervisors and trainers - the quarantine obligation does not apply.</p> <p>For entry from all other countries, proof of vaccination, a PCR, antigen or antibody test or confirmation of a survived infection must still be presented. There is also an obligation to register and quarantine. With exception of:</p> <ul style="list-style-type: none"> <li>● regular commuters</li> <li>● cross-border school and study visits</li> <li>● visits for family purposes</li> <li>● visits from life partners</li> </ul>

	<p>Vaccinated people who present proof of vaccination or a medical certificate of full immunization do not have to enter quarantine or register. The quarantine obligation also applies to minors up to the age of twelve but does not apply if the adult under whose supervision the minors are traveling is exempt from quarantine. There is one improvement for transport companies: From now on they must inform their customers about the entry requirements and the consequences of violations.</p> <p>People who only travel through Austria are not affected by the provisions of the ordinance.</p> <p>People entering by air from Spain or Cyprus must have proof of full immunization or a negative PCR test result.</p> <p>Without such evidence, you must register for pre-travel clearance and have a molecular biological test carried out immediately at the airport. The test option at the airport is free of charge.</p> <p>If, due to special circumstances, immediate testing at the airport is not possible, this can be done within 24 hours in exceptional cases. The contact details of the person to be tested are collected, but there is no immediate quarantine obligation. People who refuse to take the PCR test face an administrative penalty (penalty of up to 1450€).</p> <p>Exception: If you can show a medical certificate of recovery in accordance with Annex H or I when entering by air from Spain or Cyprus or when entering from a virus variant area or country, none of the above-mentioned proofs need to be carried. This must meet the following criteria:</p> <ul style="list-style-type: none"> <li>● The medical certificate may be issued no earlier than 14 days after the initial detection or the onset of symptoms.</li> <li>● There must be no more symptoms 48 hours before the certificate is issued.</li> <li>● The medical certificate must confirm that the infection with SARS-CoV-2 occurred in the last 90 days and had expired at the time of issue.</li> </ul> <p>The medical certificate must confirm that, despite a positive test result, the person does not pose any relevant epidemiological risk.</p> <p>You can find further information at <a href="https://www.sozialministerium.at/Informationen-zum-Coronavirus/Coronavirus---Aktuelle-Ma%C3%9Fnahmen.html">https://www.sozialministerium.at/Informationen-zum-Coronavirus/Coronavirus---Aktuelle-Ma%C3%9Fnahmen.html</a></p>
ANTIDOPING	<p><b>IFAGG Code of Discipline</b></p> <p>It's a condition of participation in IFAGG's activities that gymnasts and their assistants and representatives will follow the national and international doping rules. All gymnasts and their assistants and representatives are obligated to know the doping rules. The information of the prohibited substances and methods can be found on the WADA (World Anti-Doping Agency), <a href="http://www.wada-ama.org">www-pages</a>.</p>
PERSONAL DATA PROTECTION	<p>Personal information of registered gymnasts, coaches, judges and volunteers are used in published official competition protocols, online environment, competition's/federation's website and in social media channels. By registering to the event, the gymnasts, coaches, judges and volunteers are giving a consent to publish visual materials (photos, videos) on which they might be displayed. In case the person is not consent with the previous, LOC and IFAGG has to be informed in written form by the start of the competition. Only photographers and journalists with accreditation are allowed to take pictures and film of the event.</p>

ACCREDITATION	Delegations' accreditation will take place upon arrival. For accreditation heads of delegations are required to bring passports and proof of medical insurance of all members of the delegation.															
VISA	Please, verify if a visa is required for your travel to Austria. The LOC will be happy to assist each delegation member with an official invitation letter, provided that the request is made online before <b>September 24, 2021</b> .
